

## **CAMPGROUND RULES**

1. Only one car per campsite will be allowed to be parked in the campground.
  2. **MUST** have your camping pass with the site number posted in your vehicle at all times
  3. The campground is a community of people with close living quarters, please be respectful at all times.
  4. NO excessive noise after 11 p.m.
  5. NO alcohol
  6. NO running around
  7. **NO dogs allowed in campers or campground**
  8. **Please make sure the fire lane is left open!**
- Individuals who violate the rules will be asked to leave the campground.
  - Youth who violate the rules --- Parents will be called immediately to come and get the youth. Youth will not be allowed to stay overnight the remainder of the fair.

- **One vehicle** may be kept at the campsite. If you wish to come and go with that vehicle a \$20.00 parking pass is required and **may be purchased at the Fair Office on the north end of the Fairgrounds.**
- All vehicles must display their camping permit and parking passes with plate number and unit number. Violators may be towed at their own expense. A regular fair parking pass is required if vehicle will not be stationary at camp site.
